This Section is not empowered to approve applications for deferred service from officers who are desirous of remaining in a certain theatre.

The procedure relating to applications for deferred service until general demobilisation for one or two years is clearly laid down in GPO 54.1/45. Should there be a vacancy for which an officer is required in this theatre consideration will naturally be given to an officer who desires to work in Italy, but no guarantee can ever be given to any applicant that he will remain in the theatre of his choice, if his application for deferred service is approved.

The application of Major A.G. EVANS to serve with the Milan Economic Group is a matter for the V.P. of Economic Section, who has already submitted his recommendations to Establishment Section.

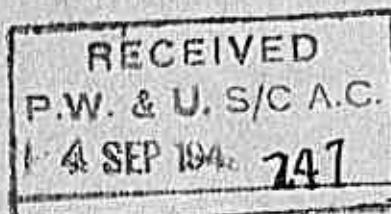
